SEBASTIAN RIVER IMPROVEMENT DISTRICT REGULAR BOARD MEETING MINUTES FEBRUARY 8, 2023

A. Call to Order

The February 8, 2023, Regular Board Meeting of the Sebastian River Improvement District (the "District") was called to order at 10:04 a.m. in the Indian River County Administration Complex, Building A, Room A-1-102, 1801 27th Street, Vero Beach, Florida 32960.

B. Proof of Publication

Proof of publication was presented showing that notice of the Regular Board Meeting had been published in *Indian River Press Journal* on September 30, 2022, as part of the District's Fiscal Year 2022/2023 Meeting Schedule, as legally required.

C. Establish Quorum

D. Additions or Deletions to Agenda

There were no additions or deletions to the agenda.

E. Approval of Minutes

1. December 14, 2022, Regular Board Meeting

A **motion** was made by Mr. Bass, seconded by Mr. Kelly approving the minutes of the December 14, 2022, Regular Board Meeting. The **motion** approving the minutes passed unanimously.

F. OLD BUSINESS

1. Update on Indian River County – 66th Avenue Permit Application

Mr. Simons advised of the responses from the most recent Request for Additional Information (RAI) had been by the County. He also advised of an update to the stormwater model for the District was necessary in response to the intended infrastructure improvements along 66th Avenue. After further discussion, a **motion** was made by Mr. Bass, seconded by Mr. Kelly adopting the new stormwater model, subject to the completion of the proposed improvements, and approving the permit. The **motion** passed unanimously.

2. Update on CR 510 West Phase

Mr. Simons advised the District was waiting for revised submittals from FDOT.

3. Update on 82nd Avenue Southern Phase

Mr. Simons advised the District had not yet received the permit application for this item.

Related to 82^{nd} Avenue, Mr. Simons advised the Board that he and Mr. Hammond had met with Commissioner Adams to discuss the maintenance required along 82^{nd} Avenue. Mr. Simons was assisting landowners in providing the County with possible options for corrective maintenance to the road. Mr. Bass confirmed the cost of that activity would not fall to the District, instead it would be either the landowners, the County, or both.

G. NEW BUSINESS

1. Consider Ratification of R&S Metalworks Gate Retrofit Proposal to SJRWMD Cost Share Program

Mr. Sakuma notified the Board of the submittal to the SJRWMD cost share program of the gate retrofit project. Because the due date was January 31st, the submittal was in advance of Board approval. There was a **motion** made by Mr. Kelly, seconded by Mr. Bass, approving and ratifying the submittal of the proposal, and authorizing staff to continue working with SRJWMD for any additional action related to the proposal. The **motion** carried unanimously.

2. Consider Approval of Indian River County First Station 7 Interlocal Agreement

Mr. Sakuma noted the draft interlocal agreement was included in the Board package. County Attorney Dylan Reingold was in attendance and available to answer any questions from the Board. There was a **motion** made by Mr. Kelly, seconded by Mr. Bass, approving the interlocal agreement, as presented. The **motion** carried unanimously.

3. Discussion Regarding Hawks Cove

Mr. Simons informed the Board that a permit application was pending and further updates would be provided, once payment and the application had been received.

H. Administrative Matters

1. Sand Mine Update

Mr. Simons provided the following updates:

- Davis Sand Mine permit renewed;
- Blue Goose Sand Mine inspected, punch list items pending;
- Wild Turkey Sand Mine inspected, punch list items pending.

2. Finance Report

Mr. Sakuma noted the finance report was included in the Board package and the District was financially sound. Mr. Bass asked about more favorable bank rates in the current fiscal environment. Mr. Wodraska confirmed SDS had found better rates through FLCLASS and would bring a recommendation back to the Board.

3. Engineer's Report

Mr. Simons had nothing further for the Board.

4. Manager's Report

Mr. Wodraska advised the Board of his discussions with representatives of the Blue Water Bay development. They were interested in pursuing a possible Unit of Development under SRID. The Board was not opposed to the idea and advised it would consider such an entity if presented.

Mr. Sakuma asked if the Board favored having Premier Citrus evaluate District canals prior to negotiating with Cates Tractor for the annual ROW maintenance. The Board directed staff to do so, similar to efforts during the prior year.

There were no further Board comments.

J. Comments from the Public for Items Not on the Agenda

There were no comments from the public.

K. Adjournment

Mr. Sakuma advised the next scheduled meeting is scheduled to occur on March 8th. There being no further business to come before the Board, the Regular Board Meeting of the District was adjourned by the Chairman at 11:03 a.m. There were no objections.

Dear Todd:

As of March 31, 2023, I will be retiring from the active practice of law, including the provision of direct legal services to the District on current and future matters ("District Matters"). I propose to assign my existing engagement with the District ("Engagement"), and to transfer all records and files on District Matters, to the law firm of Torcivia, Donlon, Goddeau & Rubin, P.A. ("TDG&R"), effective April 1, 2023.

TDG&R is a West Palm Beach law firm that has long represented many units of local government on the Treasure Coast, including several in St. Lucie County. To assure continuity in the handling of District Matters, I will be available to assist TDG&R in its provision of services to the District, on an as-needed basis, for a period of not less than 12 months following transfer.

If assignment of my Engagement with the District to TDG&R is acceptable, including transferring all files related to District Matters from my firm to Mr. Glen J. Torcivia, Esquire, please so indicate by signing the acceptance at the end of this letter and transmitting a copy of the signed letter by electronic mail to dharrell@gh-law.com and glen@torcivialaw.com.

It is of course the choice of the District as client regarding who should serve as its legal counsel, and whether all records and files on District Matters should be transferred TDG&R or to other counsel. If the District elects not to accept assignment of the Engagement to TDG&R, the District will need to select other counsel to assume responsibility for District Matters effective not later than April 1, 2023. If other counsel is to be selected, please advise me as soon as practicable, but in no event later than March 1, 2023, to whom I should transfer records and files related to District Matters.

EASEMENT

THIS INSTRUMENT Executed this /9 day of June, 1943, between Sebastian River Drainage District, a drainage district incorporated under the laws of the State of Florida, hereinafter called the Grantor, and Indian River County, a political subdivision of the State of Florida, hereinafter called the Grantee, WITNESSETH:

The Grantor, in consideration of \$1.00 and other valuable considerations to it in hand paid by the Grantee, receipt whereof is herewith acknowledged, does hereby give, grant and convey unto the said Grantee an easement upon and over the East 50 feet of the right of way of that portion of Lateral C Canal of Sebastian River Drainage District extending from the South boundary of terminal of said Lateral C canal north to the north boundary lines of Sections 11 and 12 in Township 32 South, Range 38 East, Indian River County, Florida; the said Lateral C canal being shown upon the Plan of Reclamation of Sebastian River Drainage District filed in the office of the Clerk of the Circuit Court of Indian River County, Florida.

The conditions and purposes of the Easement herewith granted being that the property upon and over which said Easement is herewith granted shall be used and maintained by Grantee solely as a public highway and county road.

The Grantee shall use and maintain said right of way in a manner which shall not be detrimental to the use of said Lateral C canal for drainage purposes and which shall not interfere with the purposes of said District or with the cleaning and maintenance of said canal by said District.

All rights acquired by the Grantee or by the general public in and to said right of way by the maintenance and use thereof shall be conditioned upon and subject to the provisions of this Easement and this Easement shall be subject to termination by the Grantor upon twelve months' notice in writing to

the Grantee in the event that the right of way herewith granted shall become necessary for exclusive use by Grantor in providing drainage in said drainage district and carrying out the purposes of said district.

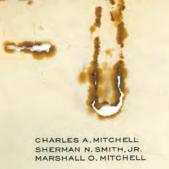

Dear Hubert:

I am enclosing herewith original and copy of Easement from Sebastian River Drainage District to Indian River County whereby the District grants to the County an easement upon and over the East 50 feet of the right-of-way of Lateral C canal from the South terminus thereof North to the North boundary line of Sections 11 and 12 in Township 32 South, Range 38 East and to be used for high-way purposes. If the Easement is satisfactory the original should be signed by the President and Secretary of the Board of Supervisors, the corporate seal affixed, the instrument attested by two witnesses and acknowledged before a Notary Public. The original should then be delivered to Douglas Baker.

I also enclose form of resolution which I suggest the Board of Supervisors adopted authorizing the Easement.

I cannot remember which of you is the President of the Board of Supervisors and the name of the President should be inserted in the acknowledgment on the Easement.

I discussed this matter with Edge Carter and if you have any suggested changes in the Easement or resolution please advise me and I shall make them. I thought it advisable to insert the clause that if the right-of-way should become necessary for drainage purposes then the Easement may be cancelled upon one year's notice by the District to the County. If the parties desire, this clause could be eliminated from the Easement but it would then have the effect of being a permanent proposition and it occurred to me that at some future time not only the District but adjoining land

owners might wish to close this proposed road and if so it would be best to have the Easement subject to termination.
